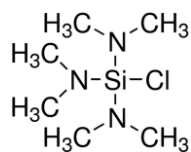

SECTION 4 FIRST AID MEASURES

GENERAL ADVICE: Consult a physician. Show this safety data sheet to the doctor in attendance. Move out of dangerous area.

PERSONAL PRECAUTIONS

METHODS AND MATERIALS

CONDITIONS FOR SAFE STORAGE

Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage.

Recommended storage temperature 2 – 8 °C.
